Call to Order

With a quorum being present, Board Chair Harte Bressler called the 86th Annual Meeting of Whatcom Educational Credit Union (WECU) to order at 5:31 p.m. on February 17, 2022.

85th Annual Meeting Minutes

Board Chair, Harte Bressler, referenced the 85th Annual Meeting minutes, which were shared via a link in the Zoom chat window. A motion by acclamation to approve the minutes via an electronic poll was made, and the minutes were unanimously approved, as submitted, by the members present.

President/CEO's Talk

A video was played that highlighted WECU's significant achievements during 2021.

WECU was recognized as one of the 200 healthiest credit unions in the entire nation and was voted Best of the Northwest Gold for the seventh year in a row. WECU's membership has also grown to over 142,000 members.

Since the onset of the pandemic in 2020, WECU has been committed to ensuring the safety and well-being of staff and members. This was accomplished by adjusting operations, developing and offering loan relief programs, and making charitable donations.

We continue to emphasize member listening and encourage feedback with the goal of providing our members with the best experience possible.

This past year, improvements have been rolled out in our online and mobile banking channels. We also offered some of the lowest interest rate loans in the credit union's history, with over \$830 million in consumer and business loans funded. \$400,000 was donated to community groups and nonprofits in the form of sponsorships, scholarships, Community Builder Grants, and our Education First Program.

Recently, our community experienced devastating storms and floods. To support our impacted community, WECU quickly rolled out consumer and business flood relief loan programs and donated \$15,000 to the Whatcom Community Foundation Resilience Fund.

In 2022, we remain committed to improving the member experience and providing value to our members. Some of our initiatives that will help to support this include:

- Enhancing the new account opening process
- Enhancing the business loan experience
- Optimizing the consumer lending experience and journey
- Enhancing consumer deposit products and credit card product suite
- Offering pre-approval and pre-qualification consumer loan offers

We will also continue to invest in our employee culture to remain an employer of choice so we can attract and retain top talent.

Jennifer thanked all those in attendance for their membership and for attending the WECU's 86th Annual Meeting.
